Decentralization And Local Government
Regions Act No. 1 of 1994

Local Government Councils
(Seats) Regulation No. 30 of 1994

To provide for the number of seats in each local government council region.

IN EXERCISE of the powers conferred by section 35 of the Decentralization And Local Government Regions Act No. 1 of 1994, I, CHARLIE NAKO, Minister of Home Affairs, make the following regulations:-

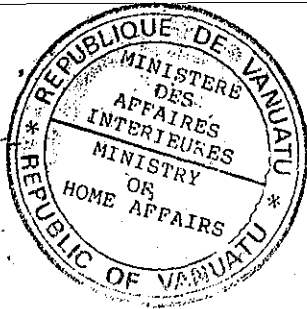
NUMBER OF SEATS IN LOCAL GOVERNMENT REGIONS

1. The number of seats in each Local Government Council region shall be as follows -
 - (a) TAFEA region 15 seats;
 - (b) SHEFA region 25 seats;
 - (c) MALAMPA region 19 seats;
 - (d) PENAMA region 15 seats;
 - (e) SANMA region 17 seats; and
 - (f) TORBA region 4 seats.

COMMENCEMENT

2. This regulation shall come into force on the day of its signature.
