

PUBLIC ORDER ACT (CAP. 84)  
ORDER NO. 4 OF 1996

IN EXERCISE of the powers conferred upon me by section 8A of Public Order Act (CAP. 84), I, ROBERT KARIE, Minister of Home Affairs, make the following Order.

PROHIBITION OF ASSEMBLY OR DEMONSTRATION

1. I hereby declare that in the interest of Public Safety and the Maintenance of Public Order, any assembly or demonstration within 100 metres of the Parliament Building on the 23rd day of February, 1996 shall be prohibited.

COMMENCEMENT

2. This Order shall come into force at 7:00 a.m on the 23rd day of February, 1996.
