FISHERIES ACT [CAP 158]

FISHERIES (BAN ON COCONUT CRABS) REGULATION

Order No. 15 of 2004

In exercise of the powers conferred on me by paragraph 34 (2)(i) of the Fisheries Act [CAP 158], I, the Honourable Maxime Carlot Korman, Minister of Agriculture, Forestry and Fisheries make the following regulation

1 Ban on taking etc coconut crabs for 3 years

- (1) A person must not take, kill, injure or have in his or her possession any coconut crab during the period starting on 1 May 2004 and ending on 31st March 2007 in Santo/ Malo Local Government Region.
- (2) Subclause (1) applies despite the quota for the coconut crabs that may be taken and the close season mentioned under the Fisheries (coconut crabs) Regulations No. 13 of 1991.

2 Offence for taking etc coconut crabs during 3 years period

If a person contravenes subclause 1 (1), the person is guilty of an offence and is punishable on conviction by a fine not exceeding VT 100,000.

3 Commencement

This Order commences on the day on which it is published in the Gazette.

LIQUOR LICENCING ACT [CAP. 52]

Liquor Licensing (Prohibition of Sale) Order No. 16 of 2004

To provide for a prohibition on the sale of liquor throughout Vanuatu.

In exercise of the power conferred on me by section 19 of the Liquor Licensing Act [CAP. 52], I, the Honourable George Wells, Minister of Internal Affairs, make the following Order:

1. Sale of Liquor prohibited

The sale of liquor in or from licensed premises throughout Vanuatu whether for consumption on or off such premises is prohibited from 12 midnight on Sunday 4 July 2004 to 12 noon on Wednesday 7 July 2004.

2. Exception

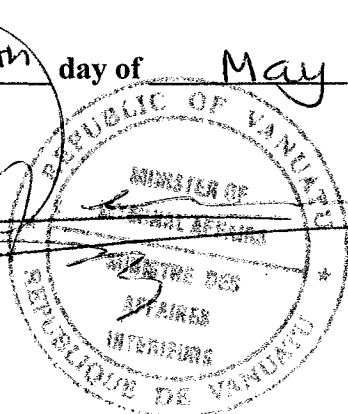
Liquor may be sold during the period referred to in section 1 within the normal hours of opening in restaurants and hotels to bona fide customers for consumption with food.

3 Commencement

This Order comes into force on the day on which it is made.

CONSTITUTION OF THE REPUBLIC OF VANUATU


Instrument of Appointment -members of the Public Service Commission

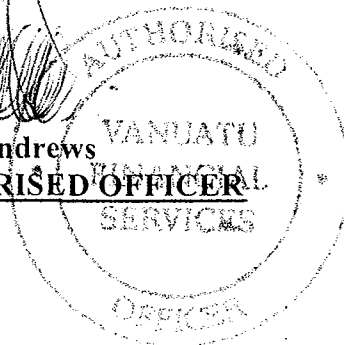

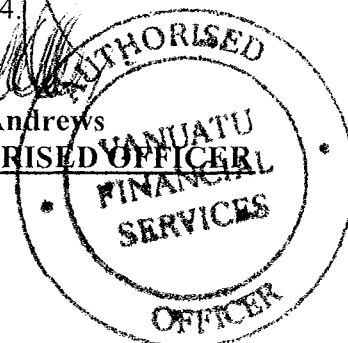
