## **Honours Regulation (Amendment)**

Order No. 27 of 2005

In exercise of the powers conferred on me by Paragraph 7(d) of the Honours Act [CAP 120], I, KALKOT MATASKELEKELE, President of the Republic of Vanuatu, on the advice of the Prime Minister make the following Regulation:

#### 1 Amendments

The Honours Regulation Order No. 46 of 1987 is amended as set out in the Schedule.

#### 2 Commencement

This Order commences on the day on which it is made.

#### SCHEDULE

#### AMENDMENTS OF THE HONOURS REGULATION ORDER NO. 46 OF 1987

#### 1 At the end of Regulation 7

Add

"(3) The President is to determine the terms and conditions of employment of the Registrar of the Order."

#### 2 Regulation 8

Delete the Regulation, substitute

- "8 Awards Advisory Committee
- (1) An Award Advisory Committee is established.
- (2) The Committee is to consist of eight members appointed by the President for two years and are eligible for reappointment.
- (3) The members are to be paid a sitting allowance at the rate of VT 2,500 for a day or part of a day for which the committee meets.".

#### 3 At the end of Regulation 9

Add

"(d) advise the Prime Minister on such matters concerning nominations of persons to receive medals and decorations under this Act.".

#### 4 After Regulation 26

Insert

#### "26A President to appoint members to fourth class

The President may appoint to be members of the Fourth Class not more than twenty members in any one year and there shall not be at any one time more than two hundred members of the Fourth Class.".

# Prohibition of the importation of "Breakfast Crackers" And "Cabin Biscuits"

## (Repeal) Order No agof 2005

In exercise of the power conferred on me by subsections 2(1) of the Import of Goods (Control) Act [CAP. 176] and Section 15(3) of the Interpretation Act [CAP 132], I, the Honourable JAMES BULE, Minister of Trade, Commerce, Industry and Tourism for the purpose of stimulating local industry, make the following Order:

#### 1 Repeal of Order No. 7 of 2005

The Prohibition of Importation of certain "Breakfast Crackers" and "Cabin Biscuits" Order No.7 of 2005 is repealed.

#### 2 Commencement

This Order commences on the day on which it is made.

# Restriction on the importation of Fiji Made Cabin and Breakfast Crackers

### Order No 30 of 2005

In exercise of the power conferred on me by subsections 2(1), (2) and (3) of the Import of Goods (Control) Act [CAP. 176], I, the Honourable JAMES BULE, Minister of Trade, Commerce, Industry and Tourism for the purpose of protecting and stimulating local industry, make the following Order:

- 1 Restriction on importation
- (1) The importation of Fiji made Cabin and Breakfast Crackers (import tariff item 1905.9000) is restricted.
- (2) The following businesses may only import 2000 kilograms of Fiji made Cabin and Breakfast Crackers biscuits:
  - (a) Fung Kwan Chee;
  - (b) Jackson Lo;
  - (c) Punjas (Vanuatu) Ltd;
  - (d) Lo Chung Chee; and
  - (e) Lo Sin Chiao.
- (3) A reference to a tariff item in subclause (1) is a reference to the tariff item listed in the Harmonized System in Schedule 1 to the Import Duties (Consolidation) Act [CAP 91].

2 Commencement and expiry of Order
This Order commences on the day on which it is made and expires on the 31<sup>st</sup> day of December 2005.
