





#### **INTERDICTION D'ABATTRE DU SANTAL (*SANTALUM AUSTRO-CALEDONICUM*) SUR LES ÎLES D'ÉFATE ET D'ANIWA**

1. L'abattage des variétés d'arbres techniquement connus sous le nom de *Santalum austro-caledonicum* ou autrement connus sous l'appellation de bois de santal est par la présente interdite sur les îles d'Éfaté et d'Aniwa pour une période de 10 ans à compter de la date de la signature.

#### **INTERDICTION D'EXPLOITER LE SANTAL (*SANTALUM AUSTRO-CALEDONICUM*) À VANUATU**

2. Aucune personne n'a le droit d'abattre un arbre de santal de moins de 15 cm de diamètre mesuré à partir de l'extérieur de l'écorce sur le tronc principal et à une hauteur de 50 cm du sol.

#### **PEINES**

3. Toute personne qui enfreint ou omet de se conformer au présent Arrêté est coupable d'une peine passible d'une amende n'excédant pas 50 000 VT.

### **SECURITY UPGRADE FEATURES OF VATU 200 NOTE**

Pursuant to section 19 (2) of the Reserve Bank of Vanuatu Act, Cap 125, the Reserve Bank wishes to inform members of the public that with effect from the 27<sup>th</sup> day of December 2006, a release of Vatu 200 notes containing upgraded security features is of legal tender and will co-circulate the current family of bank notes. It is important to note the following:-

#### **VATU 200 NOTES**

The upgraded VT200 notes match those currently in circulation with the following upgrades:

- Addition of electrotpe (watermark highlight)
- Window thread of 1.4mm width with Cleartext to read "VT200"
- Addition of Cornerstone
- Addition of Platinum
- Bears the signatures of the Minister for Finance and Economic Management, Honorable Willie Jimmy Tapangararua and the Governor of the Reserve Bank of Vanuatu, Mr. Odo Tevi.
