- (b) D. EKIPÉ SCHOOL is created as a new polling station in Area Number 3.01.02.



3. That I have taken notice and understand the provisions of subsection 23(1) of the Representation of the People Act [CAP 146], that the following persons are not qualified as candidates for election to Parliament:
 - (a) the President of the Republic;
 - (b) judges and magistrates;
 - (c) members of the police force;

- (d) members of the National Council of Chiefs, any member of the District Council of Chiefs, Island Council of Chiefs and Area Council of Chiefs, who holds the position of chairman, vice-chairman, secretary or treasurer of these councils;
 - (e) public servants;
 - (e) members of the teaching service; and
 - (g) members of the Citizenship Commission;
4. That I have taken notice and understand the provisions of section 24 of the Representation of the People Act [CAP 146], that a person is eligible to stand as a candidate for election to Parliament if he or she:
- (a) is not disqualified from voting;
 - (b) has not received a sentence including a suspended sentence of a term or terms of imprisonment which has not ended;
 - (c) is not an undischarged bankrupt;
 - (ca) is a person who is not in default of payment of any rates, charges or other debts due to the Government or a Government agency as defined in the Public Finance and Economic Management Act [CAP 244], for a period exceeding 2 months after the same becomes due;
 - (d) has attained 25 years of age; and
 - (e) is a citizen.
5. That I am not disqualified from voting;
6. That I am not an undischarged bankrupt;
7. That I am not serving a sentence of imprisonment or have not recovered a suspended sentence of imprisonment where the period of suspension has not ended;
8. That I am not a person who is in default of payment of any rates, charges or other debts due to the Government or a Government agency.

 - (a) a deposit of VT100,000;
 - (b) 2 passport sized photographs of the candidate (preferably *not* colour photographs); and
 - (c) a drawing on paper of the candidate's personal electoral symbol, unless he is sponsored by a political party with an approved symbol. The symbol should be a simple design in black and white and must not include any words.
