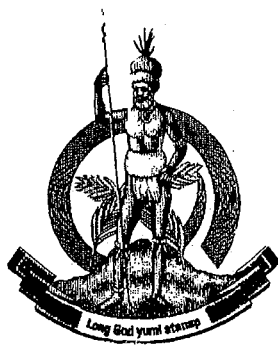

**BEING SATISFIED** that a financial emergency exists on <sup>Tongoa</sup> ~~Ambrim~~ due to recent Earthquake activity and there being no or insufficient appropriation for alleviating the same, and noting Decision 78/2009 of the Council of Ministers dated 26 June 2009 in exercise of the power conferred by Section 34C of the *Public Finance and Economic Management Act 1998*, **I HEREBY AUTHORISE** the amount of VT 23,314,225 (Twenty three million, three hundred and fourteen thousand, two hundred and twenty five vatu) to be drawn down from the Public Fund for that purpose.

The funds authorized will be allocated in accordance with schedule 1 attached hereto.
