



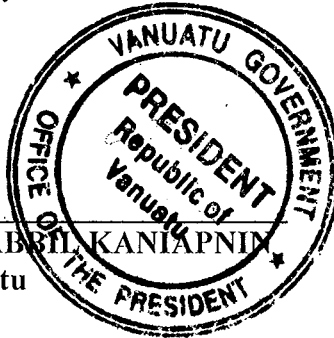
Declaration of Public Holiday Order No.106 of 2010

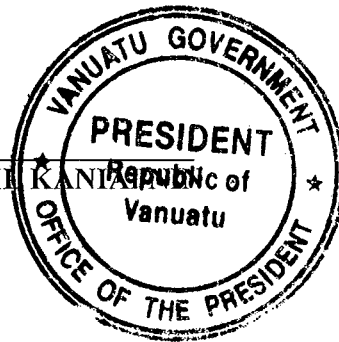
