FOREIGN SERVICES (AMENDMENT) ACT NO. 15 OF 2014

An Act to amend the Foreign Services Act No. 20 of 2013.

Be it enacted by the President and Parliament as follows-

1 Amendments

The Foreign Services Act No. 20 of 2013 is amended as set out in the Schedule.

2 Commencement

This Act commences on the day on which it is published in the Gazette.

SCHEDULE

AMENDMENTS OF FOREIGN SERVICES ACT NO. 20 OF 2013

1 Section 1 (Definition of Honorary Consul)

After "21(1)", insert "or 21A(1)"

2 After section 21

Insert

"21A Appointment of Honorary Consul under the Consular Program

- (1) The Minister, on the approval of the Council, is to appoint a person as Honorary Consul under the Consular Program of the Government of Vanuatu.
- (2) A person must not be appointed as Honorary Consul under this section unless:
- (a) the person is qualified and capable of carrying out the functions of a Honorary Consul; and
 - (b) the person must be committed to work in partnership with the Government in ensuring the interests and priorities of the Government are met; and
 - (c) the person has no record of criminal conviction; and
 - (d) the person has no bankruptcy records inside or outside Vanuatu; and
 - (e) the person contributes at least US\$350,000 to the Vanuatu Government to be used for funding any of the following:
 - (i) a Vanuatu overseas mission; or
 - (ii) a Vanuatu Government Approved Project; and

- (f) the person agrees to generate at least 60 international company sales through an authorised agent of the Vanuatu Financial Services Commission; and
 - (g) the person agrees to promote tourism and investment for Vanuatu abroad; and
 - (h) the person has undergone the probity checks by the Director of the Department of Foreign Affairs and is recommended by the Director as suitable for this appointment.
- (3) A Honorary Consul appointed under this section is to hold office for a period of 5 years and is eligible for reappointment.
- (4) To avoid doubt, sections 22, 24, 25, 26 and 27 apply to a Honorary Consul appointed under this section.

21B Honorary Consul not a Public Office

To avoid doubt, the office of a Honorary Consul under section 21 or 21A is not a public office.”

"21A Nomination de consul honoraire dans le cadre du programme consulaire

- 1) Le ministre nomme après aval du Conseil, une personne en qualité de consul honoraire conformément au programme consulaire du gouvernement de Vanuatu.
- 2) Une personne ne doit être nommée consul honoraire en vertu du présent article que si elle:
 - a) est qualifiée pour et capable de s'acquitter des fonctions de consul honoraire;
 - b) est vouée à travailler en partenariat avec le gouvernement et s'assurer que l'intérêt du gouvernement et ses priorités sont respectées;
 - c) n'a pas de casier judiciaire;
 - d) n'a pas d'antécédents de faillite à Vanuatu ou ailleurs;
 - e) contribue au moins 350 000 \$US au gouvernement de Vanuatu pour servir au financement de l'un quelconque des objets suivants:
 - i) une mission de Vanuatu à l'étranger; ou
 - ii) un projet agréé du gouvernement de Vanuatu;
 - f) s'engage à générer la vente d'au moins 60 compagnies internationales par le truchement d'un agent autorisé de la Commission des Affaires financières de Vanuatu;

- g) s'engage à promouvoir le tourisme et l'investissement pour Vanuatu à l'étranger; et
 - h) a été soumise aux contrôle de probité menée par le directeur du service des Affaires étrangères et qu'elle est recommandée par le directeur comme étant apte à être nommée.
- 3) Un Consul honoraire nommé conformément au présent article occupe cette charge pour un mandat de cinq ans renouvelable.
- 4) Pour écarter tout doute, les dispositions des articles 22, 24, 25, 26 et 27 s'appliquent à une consul honoraire nommé en application du présent article.

21B La Fonction de consul honoraire n'est pas une charge publique






