Liquor Licensing (Prohibition of Sale) (Amendment) Order No. 24 of 2015

In exercise of the powers conferred on me by section 19 of the Liquor Licensing Act [CAP 52], I, the Honourable CHARLOT SALWAI TABIMASMAS, Minister of Internal Affairs, make the following Order.

1 Amendments

The Liquor Licensing (Prohibition of Sale) Order No. 22 of 2015 is amended as set out in the Schedule.

2 Commencement

This Order commences on the day on which it is made.

SCHEDULE

AMENDMENTS OF THE LIQUOR LICENSING (PROHIBITION OF SALE) ORDER NO. 22 OF 2015

1 Subclause 1(1)

Repeal the subclause substitute

“(1) The sale of liquor by holders of:

- (a) an Urban General Off-Licence;
- (b) a Rural Off-Licence,
- (c) a Limited Off-Licence,
- (d) a Club Licence,
- (e) an Occasional Licence, or
- (f) a Night Club License,

is prohibited from 12 o'clock midday on Wednesday 15 April 2015 to 12 o'clock midday on Monday 20 April 2015.”

Instrument of Direction to Government Agencies Order No. 25 of 2015

In exercise of the powers conferred on me by subsection 16(1) of the National Disaster Act [CAP 267], I, the Honourable JAMES BULE, Minister of Climate Change, Adaptation, Meteorology and Geo-Hazards, on the advice of the National Disaster Committee, make the following Order.

1 Direction

The following direction is made to the Department of Customs and Inland Revenue (through the Director) to prepare general VAT and Customs Duty conditions for suppliers of planting materials including seeds and gardening tools, that will apply for a period of 2 months commencing on 14 April 2015 and ending on 12 June 2015, to assist persons whose gardens have been damaged or destroyed by cyclone Pam.

2 Commencement

This Order is taken to have commenced on 14 April 2015.

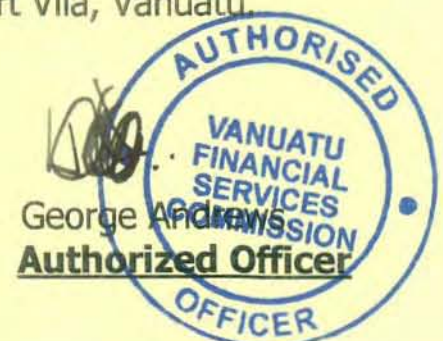
