FISHERIES ACT NO. 10 OF 2014

Fisheries Regulation (Amendment)

Order No. 172 of 2015

In exercise of the powers conferred on me by paragraph 147(2)(a) of the Fisheries Act No. 10 of 2014, I, the Honourable CHRISTOPHER EMELEE, Minister of Agriculture, Livestock, Forestry, Fisheries and Biosecurity, make the following Order.

1 Amendments

The Fisheries Regulations Order No. 28 of 2009 is amended as set out in the Schedule

2 Commencement

This Order commences on the day on which it is made.

SCHEDULE

AMENDMENTS OF THE FISHERIES REGULATION ORDER NO. 28 OF 2009

1 Clause 62

- (a) Delete "harvest" (wherever occurring), substitute "harvest and process";
- (b) Delete "harvesting" (wherever occurring), substitute "harvesting, and processing"

2 Clause 62A

Repeal the clause, substitute

"62A Quota of beche-de-mer that may be harvested and processed during an open season

- (1) The Director may from time to time publish in the Fisheries Management Plan the total quota of each species of beche-de-mer that is permitted to be harvested and processed in an open season.
- (2) A person must not harvest or process beche-de-mer or species of beche-de-mer anywhere in Vanuatu once the total quota under subclause (1) has been met.
- (3) In addition to subclause (2), a person must not export beche-de-mer which has been harvested or processed in contradiction of subclause (1).
- (4) A person who contravenes subclause (2) or (3), commits an offence punishable on convictions:
 - (a) in the case of an individual – by a fine not exceeding VT500,000;
or
 - (b) in the case of a company – by a fine not exceeding VT1,000,000."

2 Schedule 27

Repeal the Schedule.

Declaration of Marine Reserve Order No. 173 of 2015

In exercise of the powers conferred on me by subsection 102(1) of the Fisheries Act No. 10 of 2014, I, the Honourable CHRISTOPHER EMELEE, Minister of Agriculture, Livestock, Forestry, Fisheries and Biosecurity, after consultation with the owners of adjoining land, parties with traditional tenure rights of the said waters and the Torba Provincial Government Council, make the following Order.

1 Declaration of Marine Reserve – Vot Tanda

The 2058.47 square kilometre of Vanuatu waters and seabed underlying those waters located around the island of Vot Tanda and within the coordinates set out in the Schedule are declared as a marine reserve.

2 Commencement

This Order commences on the day on which it is made.

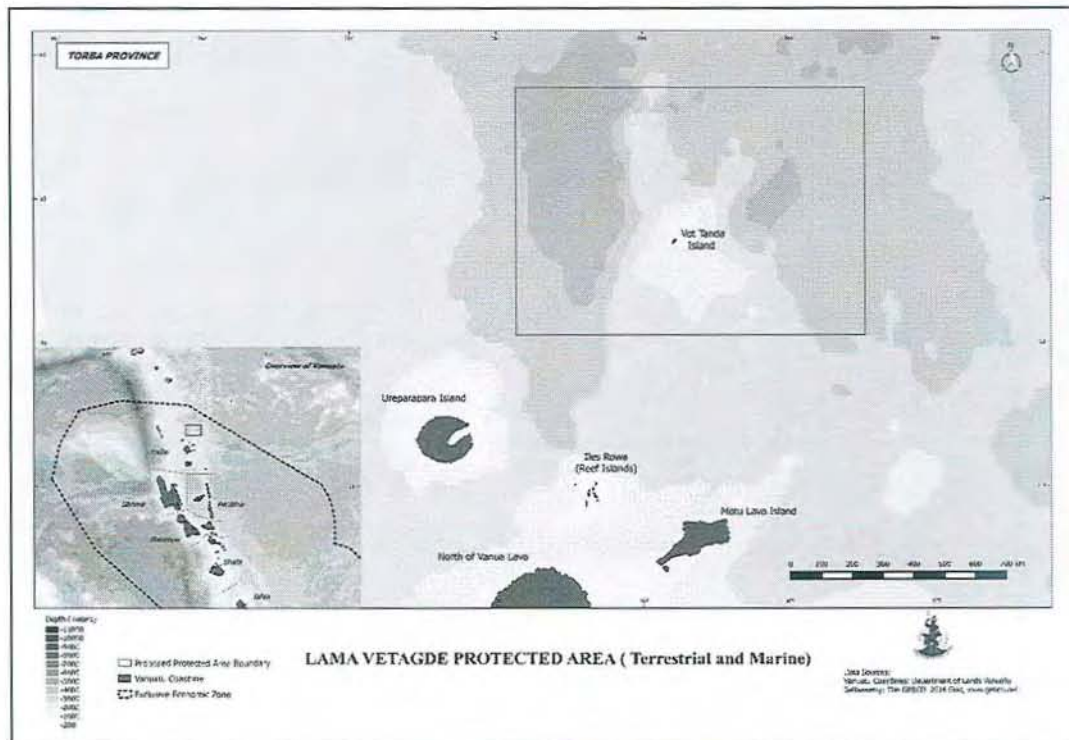

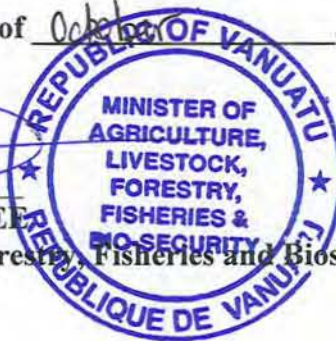
