THE FEES OF THE HIGH COURT ORDINANCE, 1920.

Western Samoa.

No. 2,1920.

AN ORDINANCE

made by the Administrator of the Territory of Western Samoa with the advice and consent of the Legislative Council of that Territory, and in pursuance of the Samoa Constitution Order, 1920.

1. This Ordinance may be cited as the Fees of the High Court Ordinance, 1920.
2. This Ordinance shall come into operation on the fifth day of May, 1920.
3. There shall be payable in respect of proceedings in the High Court of Western Samoa the fees set forth in the Schedule hereto. Such fees shall be paid by means of stamps.
4. If it appears to the satisfaction of the Court that any party is unable or ought not to be called upon to pay any of the fees mentioned in the said Schedule, the Court may dispense with the payment thereof, or may reduce the amount thereof.
5. The Court or the proper officer thereof may refuse to take any step in the course of any proceedings until the proper fee therefor, together with all other fees already due and unpaid in respect of the same proceedings, have been fully paid.
