**NOTICE OF CHARGE ON BASE TARIFF FOR THE  
SUPPLY OF ELECTRICITY (No.2) 2010**

**I, TUISUGALETAUA SOFARA AVEAU**, Minister responsible for the Electric Power Corporation, pursuant to section 23A of the Electric Power Corporation Act 1980 give notice that:

1. The charge to be applied on the base tariff charged for the supply of electricity is 8.37%.
2. The charge is to compensate for the cost of fuel used for the supply of electricity.
3. This Notice commences on 1 February 2010.
4. The Notice of Charge on Base Tariff for the Supply of Electricity (No.1) 2010 dated 24<sup>th</sup> of December 2009 is revoked.
